The AHPA reserves the right to accept or reject any nomination. If rejected, your nomination fee will be refunded in full. The nominated horse remains nominated and eligible to show in the 2019 AHPA Hunter Pleasure Futurity regardless of sale or transfer of ownership.

All horses competing in the AHPA Half-Arabian Hunter Pleasure Futurity must have parentage DNA verified to a purebred parent on file at the AHA office before they are allowed to compete.

This nomination is nonrefundable. Full payment must accompany this form to be accepted. Any bounced checks will be subject to a late fee, and party will be responsible for any and all costs and fees incurred with collection, including but not limited to attorney's fees.
